1. **CALL TO ORDER**

Reeve Rydholm called the meeting to order at 6:30 pm.

2. **ADOPTION OF THE AGENDA**

3. **DECLARATION OF PECUNIARY INTEREST**

There were no declarations of pecuniary interest on the part of any member of Council.

4. **DEPUTATIONS AND PETITIONS**

4.1 Kevin Holland, Chair, Conmee Highway Committee

Mr. Holland attended Council to provide an update on the activities of the Highway Committee. He noted that the Committee has had several meetings with Stantec and MTO and had participated in the PIC 2 meeting held on August 11th. At the PIC2 meeting, the Committee provided residents with copies of the maps of the four remaining routes with the social and financial impact of each of the routes on the back. The overwhelming majority of people who Committee members spoke to at the PIC2 meeting were grateful for the Committee's assistance as MTO/Stantec representatives were not very forthcoming with information. A number of people originally thought that none of the routes would impact them, until the Committee members provided them with the information on the financial impact to the Township.

Mr. Holland noted that the Committee sent invitations to Mr. Bill Mauro, MPP, Mr. John Rafferty, MP and Mr. Michael Gravelle MPP, asking them to attend the PIC2 meeting for informational purposes. Only Mr. Rafferty sent a representative and then met with some Committee members at a later date. Mr. Mauro required a resolution from Council and Mr. Gravelle did not respond.

Mr. Holland also noted that once the public had been given the information on the financial impact to the Township, most people were in favour of the route known as the Conmee Alternative, or BCD4.

Mr. Holland advised Council that the Committee was looking for approval for three things:

1. To appoint Mr. Glen Campbell to the Highway Committee. Mr. Campbell has already provided valuable assistance to the Committee, and he was involved in the original study in the 1970's.
2. To approve of a mass mailing of the route information to the residents of Conmee.
3. To approve of a public meeting, tentatively set for November 10, 2010.

Mr. Holland noted that Council already had a draft copy of a resolution that states Council's position that route BCD4 is the only viable option for Conmee Township. Mr. Holland urged Council to pass the resolution as the numbers support that conclusion.

Mr. Holland also noted that the social impact to the Township was considered during the 1977 study, but that the 2010 study does not take this into consideration. Mr. Holland questioned whether this was done because removing the social impact to the Township would make the MTO preferred route look better.

Mr. Holland advised that the Committee would be making a presentation and comments to Stantec/MTO on the BCD4 route at our next meeting with them tentatively scheduled for October.

Councillor S. Hunt was not comfortable with some concerns that maybe should be addressed in this resolution.

1. Will the Township assist the property owners that will be affected by choosing route BCD4. Mr. Holland had previously stated that Stantec had indicated to him that the route BCD4 could be adjusted enough to avoid the two residential properties that might be affected.
2. Would the Township of Conmee have to assume the responsibility and cost of maintenance to the present portion of the existing highway 11/17 through Conmee? Kevin Holland asked permission to respond. The Committee felt it was imperative that we submit our views through a resolution, choosing the route BCD4 and worry about negotiating ownership of the present highway when the time comes.

Councillor S. Hunt commended the Highway Committee for all the work they have done in order to present our case to Stantec and MTO but also felt it was imperative all Councillors were totally aware of the implications if we have to assume the maintenance of the present highway.

Councillor S. Hunt requested to defer the resolution to the next meeting when a full Council was present. Request was denied.

Reeve Rydholm thanked the Committee for their attendance and for all of their work on this issue.

Council was notified that Sandei Beattie has submitted her resignation from the Library Board. Council requested that a letter of appreciation be forwarded to Ms. Beattie and the vacancy be advertised in the next newsletter.

8.2 Resolution re Highway

Whereas, The Ministry of Transportation of Ontario has undertaken a route planning and environmental assessment study for the twinning of highway 11/17 between Kakabeka Falls and Shabaqua corners, known as plan # GWP6054-03-00

And whereas, the route will traverse the Township of Conmee,

And whereas, the Council of the Corporation of the Township of Conmee believe that the results of the current study supports the results of a study done by the Ministry of Transportation of Ontario in 1977

And whereas, the conclusions reached by Conmee council in 1977 showed a severe negative economical impact to the Township as a whole,

And whereas, the council of 1977 proposed an alternate route known as the Conmee Route (currently designated as BCD4),

And whereas, the Ministry of Transportation of Ontario in 1977 recognized the Conmee alternative as a very viable option,

And whereas, the Ministry of Transportation of Ontario engineers in 1977 studied and refined the Conmee alternative and shifted the route eastward so that it became, by Ministry of Transportation of Ontario criteria, the best scoring of all routes proposed through the Township of Conmee,

And whereas, research by the Township of Conmee in 2010 continues to support these conclusions of the 1977 study,

Now therefore be it resolved, that the Council of The Corporation of the Township of Conmee hereby deem the route designated as BCD4 to be the only viable route to preserve, maintain and protect the existence of the Township of Conmee.

The Clerk read a submission by Councillor Mary-Lynne Hunt also in favour of this route as the only viable option.
